Single license for Branch Office with Inclusion of all premises in the same license.

Nomination of Responsible Person

Required uniform enforcement of FSSAI Nomination Process.

A single person is responsible for conduct of business at different premises as nominee.

We request for rationalization of labeling requirements by FSSAI in line with US FDA and EU guidelines.






- Clarity is required on some of P & L Regulations.
- Height of Numerals on the label
 - ✓ Is it applicable only to Net quantity declarations?
 - \checkmark Is it applicable to any numerals on the label ?
- If height of all numerals is as per the weight / volume, then it is not possible to incorporate required Labeling regulations on small/price point packs.



- Clear Guidelines on Health and Nutrition claims is required.
- Protein rich products like Paneer & Cheese contains 20% protein.
- Protein is nutritious, helps in muscle building and endure power.
- Claims like "Power of Protein" is not violation of regulations.





Food Sample Analysis and Prosecution

Sub Judicial matters shall not be published in any form of media.

Variation in analysis of food between state labs and CFL reports. **Food Sample Analysis and Prosecution**

The food related cases would be better to prosecute in Chief Judicial Magistrate courts.

Food Safety Appellate Tribunal is not yet established in some of the states.
