Prevention and Control of Infectious and Contagious Diseases in Animals Act, 2009.

No.Sankirna 2010/ C.R.347/ ADF-4.—In exercise of the powers conferred by section 43 of the Prevention and Control of Infectious and Contagious Diseases in Animals Act, 2009, the Government of Maharashtra with the prior approval of Central Government hereby makes the following Rules, namely:—

#### 1. Short Title and Commencement.—

These Rules may be called the Maharashtra Prevention and Control of Infectious and Contagious Diseases in Animals (Check Post and Quarantine Camp, Manner of Inspection, etc.) Rules, 2012.

#### 2. Definitions.—

- (a) In these Rules unless the context otherwise requires,—
- (i) 'Act' means The Prevention and Control of Infectious and Contagious Diseases in Animals Act, 2009;
- (ii) 'Department' means the Agriculture, Animal Husbandry, Dairy Development and Fisheries Department of the Government of Maharashtra;
  - (iii) 'Director' means the person notified as Director under Clause (g) of Section 2 of the Act;
  - (iv) 'Form' means a form appended to these Rules;
  - (v) 'section' means a section of the Act.
- (vi) 'Identification' means identifying the animals by way of ear tagging, tattooing, marking, photographs, microchips, etc. or any other suitable system.
- (b) Words and expressions used in these Rules and not defined above shall have the same meanings as assigned to them in the Act.

## 3. The manner of inspection and the period of detention at a Check Post or at Quarantine Camp.—

- (a) In order to ascertain whether the animal is infected with any of the scheduled disease, the animal stopped at the check post or detained in the quarantine camp shall be inspected by the veterinarian in charge of check post or quarantine camp or staff of the Department duly authorised for this purpose, for the following;
  - (i) movement and gait
  - (ii) whether dull, depressed, normal or exhibiting excited behaviour
  - (iii) increase in body temperature
  - (iv) ulcer in the mouth, feet or udder
  - (v) excessive lacrimation, nasal or vaginal discharge
  - (vi) sweating and shivering
  - (vii) dryness of the skin, alopecia, skin rashe
  - (viii) weakness
    - (ix) bleeding through natural orifices
- (x) oedema or swelling at dewlap region or any other part of the body भाग चार-ब-५अ

- (b) The veterinarian in charge of check post or quarantine station or staff of the Department duly authorised for this purpose shall also collect the necessary samples for laboratory examination, if required.
- (c) The veterinarian in charge of check post or staff of the Department duly authorised for this purpose may detain animals, at the check post for a period not exceeding 12 hours for the purpose of inspection, compulsory vaccination and identification or marking etc. For the animals vaccinated at the check post, the animal owner shall be given a vaccination certificate as prescribed under section 8 of the Act.
- (d) After examination of the animal, the veterinarian in charge or staff of the Department duly authorised for this purpose shall either allow entry of the animal into the Controlled Area or Free Area by issuing an Entry Permit in Form A appended to these Rules; or shall direct to transport the animals to the Quarantine Camp.
- (e) The cost of examining, vaccinating, ear-tagging the animal or any other activity at the check post shall be fixed by the Director from time to time and shall be borne by the animal owner.
- 4. Form of permit to be granted by the veterinarian in charge of Quarantine Camp or the staff of Department duly authorised for this purpose.
- (a) The veterinarian in charge of the quarantine camp or staff of the Department duly authorised for this purpose shall detain the following animals:—
  - (i) Which are suffering from any scheduled disease; or
  - (ii) Which have come into contact with or have been kept in the proximity of animals infected with scheduled disease; or
    - (iii) Which are transported by the in charge, check post as detailed in rule 3 (d); or
  - (iv) Which are the species notified under section 10 of the Act while exiting from the infected area and shall be subjected to a quarantine of 14 days in a Quarantine Camp.
- (b) The veterinarian in charge of Quarantine Camp or staff of the Department duly authorised for this purpose shall give an official acknowledgement to the animal owner or the person duly authorised by him, on his behalf for the animals detained in the Quarantine Camp. The Detention Acknowledgement shall be in Form B appended to these rules.
- (c) During quarantine, the animals shall be suitably given identification and shall be marked. Animals shall be examined regularly for any scheduled disease, and shall be vaccinated against the scheduled disease and provided with veterinary treatment, if required. If animals are vaccinated, the animal owner or the person duly authorised by him, on his behalf shall be provided with a vaccination certificate as required in section 9 of the Act.
- (d) After successful quarantine, the veterinarian in charge of Quarantine Camp or staff of Department duly authorised for this purpose shall release the animals to the owner or person duly authorised by him on his behalf and also grant the Quarantine Release Permit in Form C appended to these Rules, under his signature. Form C shall also serve as Entry Permit as required by section 15 (2) of the Act.
- (e) The cost of maintenance and vaccination of the animals during the period of quarantine shall be fixed by the Director from time to time and shall be borne by the animal owner.
